1 Pursuant to the parties' stipulation as to form, and good cause appearing for the entry
2 Judgment, and in accordance with the Court's decision dated October 8, 2009,


3 It is hereby ADJUDGED, ORDERED AND DECREED that Judgment is entered in favor of
4 the District on the Amended Verified Petition For Writ Of Mandamus And Amended Verified
5 Complaint For Declaratory And Injunctive Relief, as follows:

6 1. The San Francisco Unified School District is entitled to a Peremptory Writ ordering
7 Respondents to reimburse the District for claims submitted by the District after September 10, 2009
8 for covered "LEA services" that do not meet the requirements of the "free care" principle but are
9 otherwise reimbursable in accordance with state and federal law.

10 2. Upon entry, the Judgment shall become final.

11 3. Any claim for attorneys' fees and costs in this action shall be determined by separate
12 motion or by agreement of the Parties.
